SPECIAL CONDITIONS FOR THE PROVISION OF THE LICENSED INFORMATION TO COMPANIES OF THE SUBSCRIBER GROUP

First.- Scope of Application

The special conditions set forth hereto shall exclusively apply to the redistribution of the Licensed Information for the exclusive Internal Use of the companies belonging to the Subscriber's Group (hereinafter referred to as "Beneficiary Entities"). These special conditions shall not be applicable to circumstances other than the previously mentioned.

Second.- License

In signing this Annex, and as long as it remains in force, BMEMD grants the Subscriber, in addition to the license specified in the Agreement, a non-exclusive and nontransferable license for the Redistribution of the Licensed Data, referred to in the first Clause hereto, for the internal use by the Beneficiary Entities detailed in this Annex.

Third.- Obligations of the Subscriber

3.1 The Subscriber, prior to redistributing the Licensed Data, shall inform BMEMD of the list of companies which shall be considered as Beneficiary Entities pursuant to this Agreement. Such list shall be included as Annex to this document. In the abovementioned list, the Subscriber shall include the name and postal address of all the referred Beneficiary Entities.

BMEMD reserves the right to reject changes in the list of Beneficiary Entities communicated by the Subscriber if, as a result of a previous relationship with any such Entity, information gathered on them and/or other analogous circumstances, BME believes that the Subscriber cannot comply with the obligations foreseen in the Agreement with regard to the new entities that the Subscriber desires to include in the Agreement as Beneficiary Entities.

3.2 The Subscriber has the responsibility to keep the information on its Beneficiary Entities updated at all times in accordance with this communication, for which the Subscriber shall send an updated Annex to BMEMD every time there is a change concerning the Beneficiary Entities.

3.3 The Subscriber is the sole responsible before BMEMD to guarantee that the Beneficiary Entities included in the above-mentioned Annex know and comply with the obligations

foreseen in the Agreement, as well as to ensure that they are aware and understand the conditions established in the Agreement for the data usage redistributed by the Subscriber and the restrictions applicable to such usage and especially, but not limited to, the following:

- a) The Beneficiary Entities can only make an Internal use of the BMEMD Data that they receive from the Subscriber and in any manner shall they be entitled to redistribute it to third parties.
- b) The Beneficiary Entities acknowledge and accept the right of BMEMD to conduct Technical Audits, as well as the obligation to cooperate with BMEMD while these are being undertaken upon BMEMD's request, in accordance with the clauses related to Technical Audits foreseen in the Agreement.
- c) That the Beneficiary Entities are aware of BMEMD intellectual and/or industrial property rights over the data as well as, if applicable, the intellectual and/or industrial rights of the data when such rights belong to third parties.
- d) Any other specifications foreseen in the Agreement.
